Exhibitor Agreement Overview

Location: The exhibit hall is located in the gymnasium at *King George Elementary School, 10381 Ridge Road (Routes 3 & 205), King George, Virginia 22485*. Spill over will be in the hallways of the school.

Carpet: The gymnasium and the hallways are not carpeted.

Dismantling: All exhibits must be dismantled and removed from the exhibit hall area by the exhibiting company at its own expense no later than 6:00 p.m. on Saturday, April 24th.

Loading/Unloading: Exhibitors will be able to load/unload through the back door of the gymnasium.

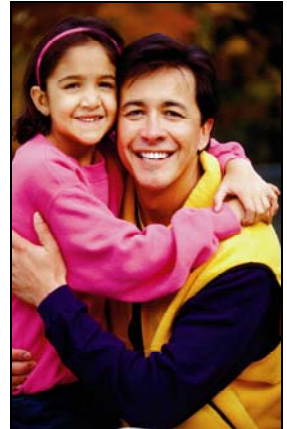

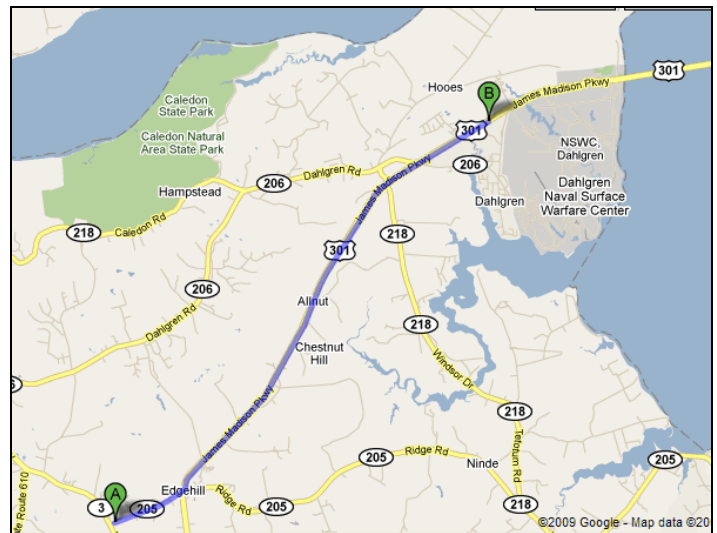

Map is an approximate showing of hotel locations.

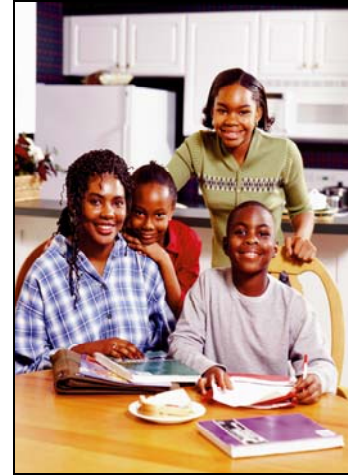

Exhibitor Terms and Conditions

1. **Administration:** The Planning Committee has assigned all administrative duties to the NNKDAF Secretary (Samantha Romano). All correspondence should be sent to: NNKDAF, c/o Samantha Romano NSWC Federal Credit Union, P.O. Box 519, Dahlgren, VA 22448. Best method to contact:

2. **Character of Exhibits:** The NNKDAF Planning Committee reserves the right to decline or prohibit any exhibit or part of an exhibit, or prohibit or restrict any activity within the exhibition area which, in its opinion, is not suitable.
3. **Contract Payment & Cancellation:** "For-profit" exhibitors, please send in your agreement form and exhibit fee in the amount of \$200 to secure your exhibit space. Exhibitor agrees that an application accepted by NNKDAF without a exhibit shall be deemed as invalid and a space will not be reserved for the exhibitor. Exhibitor understands and agrees that no portion of the exhibit fee is refundable and exhibitor is liable for the total exhibit fee.
4. **Door Prizes:** Each exhibitor is required to provide a door prize to be given away on the afternoon of April 24th.
5. **Carnival Game:** On Friday, April 23rd, exhibitors will have a chance to meet with conference attendees. To incorporate a family fun atmosphere, we are requiring each exhibitor to provide a carnival game for all ages to play. Please note the type of carnival game you will have at your space, so that we can make sure there are no duplicates.
6. **Services:** Exhibitor acknowledges the difficulty in establishing a precise value for services provided by NNKDAF prior to the conclusion of the exhibition. Consequently, exhibitor agrees that the provisions of this paragraph represent an agreed measure of compensation and are not to be deemed or constructed as a forfeiture or penalty.
7. **Contract Return:** Upon acceptance of this reservation by a duly authorized representative of NNKDAF, this document becomes a binding agreement between NNKDAF and exhibitor. The person signing this document expressly represents and warrants NNKDAF that the signer is authorized by the exhibitor to bind it to the terms and conditions, hereof, which the signer has read and accepts on behalf of the exhibitor. The undersigned hereby irrevocably and unconditionally guarantees to NNKDAF that the exhibitor will promptly and fully pay and perform all obligations of the exhibitor to NNKDAF, whether now existing or hereafter arising.
8. **Equipment Included with Table Space:** Each table space measures 8 x 10. Each setup includes (1) 8-foot table, (2) folding chairs, (1) table cloth, (1) sign, and (2) box lunches. **Carpeting:** NNKDAF does not provide carpeting for your table space.
9. **Electrical, Internet and Telephone Connectivity:** Please indicate on the Exhibitor Contract if electrical, Internet or telephone connectivity is needed. Every possible effort will be made to provide, however, there is no guarantee of electricity, Internet or telephone capabilities for this event.
10. **Materials Handling Charges:** NNKDAF does not cover Materials Handling Charges. Any large items that you cannot personally carry on to the exhibit floor are subject to material handling charges.
11. **Early Table Space Breakdown:** Breakdown before the end of the event is strictly prohibited. Any exhibitors who leave early will be subject to an early-breakdown penalty fee of \$50.00.
12. **Exhibit Table Space Assignments:** Vendors will be assigned table spaces on a first come first serve basis.
13. **Exhibit Setup:** Friday, April 23rd – 4:30 p.m.
14. **Exhibit Breakdown:** Saturday, April 24th – 6:00 p.m.
15. **Exhibit Hours:** Friday, April 23rd – 6:00 – 9:00 p.m. Saturday, April 24th – 7:00 – 5:00 p.m.
16. **Parking:** Parking attendants will assist exhibitors in finding the appropriate parking lot.
17. **Rental Fees:** The rental fees for exhibit table space will be \$200.00 for those organizations/companies selling services. Non-profit agencies will not be charged for a space but **MUST** register in order to receive a table.
18. **Smoking Policy:** King George Elementary School is a smoke free facility.
19. **Unwritten Rules:** Anything not covered by these rules is subject to the judgment of the NNKDAF Planning Committee. Each exhibitor, for himself and his employees, agrees to abide by the above terms and conditions and any amendments or additions that may hereafter be established or put into effect by the Committee Chairperson, Facility, or County Government (local fire and police laws or codes).
